What is The Quilt?

- Established in 2001
- A collaboration of 30 leading advanced regional networking organizations in the U.S. with 7 U.S. and international affiliate participants
- Aim is to promote consistent, reliable, interoperable and efficient advanced networking services that extends to the broadest possible community
- Projects are volunteer led and self-supporting
- Starting in 2008, funding provided by member participation fees



Why The Quilt

- The Quilt provides a forum for members and affiliates to cooperate and collaborate on matters of common interest.

 - services
 - vendors
 - business models
 - relationships with national and international R&E networking community
- Quilt members identify and support projects which;
 - assist participants in providing a broad range of networking services to constituents
 - facilitate innovative and successful technical projects
 - promote end-to-end continuity and delivery of advanced network services

Commodity Internet Services

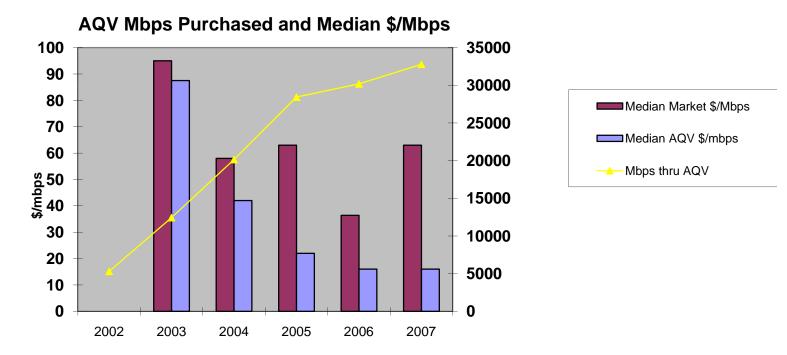
Objective: Aggregate the buying power of the Quilt members and authorized buyers to get the best value and lowest pricing commodity internet services.

- Distributing fifth RFP in December 2009
- Vendors are chosen on merit
- Currently six vendors participate in the program



Historical Estimated Savings

Since the project's inception in 2002, Quilt Authorized Buyers have saved a cumulative total of \$54M.

Network Facilities Project

- Objective: In support of Quilt members, developing business agreements with vendors who have a comprehensive network delivery infrastructure and are able partner with The Quilt in the delivery and development of our research and education networks throughout the United States.
- Two different programs differentiated by types of business agreements:
- Vendor partners meet Quilt member requirements for discounted purchasing, RFP process requirements and account support.



RON Case Study Collection

- Objective: To enrich and deepen the content of the original Quilt business model review, to update the case studies of the 'SURA Optical Cookbook', and to share the history, knowledge and experience of R&E optical network organizations with the broader R&E community.
- Joint project supported by The Quilt and MIDnet
- Completed 22 interviews and finalized 15 case studies

Peer Review Service

Objective: Through its peer review service, The Quilt wishes to tap into its member resources to benefit peer organizations in the sharing of knowledge and experience managing advanced R&E networks.

- The Quilt's role is to coordinate review requests, convene a panel of peer reviewers and provide project management support for the review process
- Completed first peer review project in September 2008

Summary Findings

- No single business model, no single recipe for success
- Mission statements are unique, but they all have similar elements:
 - Supporting research and education
 - Enabling research and education
 - Providing advanced network technologies and applications
- Commonalities in the following program areas:
 - Outreach and community building
 - Lessons learned
 - Future directions



Summary Findings

- Of the 30 member organizations, the majority are university-based organizations
 - 13 are 501c3's
 - 4 are governed by the state board of regents and managed by a university



Operations and Management

- Of the 21 operational networks interviewed
 - Staffing levels ranged from 1 to 110
 - -43% Staff a 24 x 7 NOC
 - 38% outsource some or all of NOC services
 - 62% outsource some or all of remote hands
 - Majority own rather than lease network equipment



Services and Pricing

- Of the 21 operational networks interviewed
 - 92% offer services beyond Layer 1
 - Six charge an annual membership fee to cover operational costs with additional fee for service structure for transport costs
 - 13 price transport services based on bandwidth
 - Slightly more than half include access to national backbones in transport fee



Outreach & Community Building

- Community workshops
- Dedicated staff
- Word of mouth
- Showcase special projects to promote network capabilities



Lessons Learned

- Outreach and community building are important
- Bringing people together provides great value
- Add value by providing leading-edge services that no one else can or will provide
- Be an enabler for research and education
- Do what is in the best interest of your members
- Leverage opportunities



Future Directions

- Expand fiber footprint Focus on 'last mile'
- Evaluate existing services
- Develop new services
- Investigate peering relationships that provide cost effective solutions
- Expand beyond the realm of the physical network
- Research new 'market': K-12, libraries, health care, etc.
